Application Policies

1. You must be enrolled in a full course of study and be in good academic and disciplinary standing at the time of application. The exchange coordinator will consult your administrative adviser (dean) during the selection process, and if you are selected as a member of the group, will continue to do so periodically until the time of departure to ensure your continued eligibility for participation in the program.
2. Should the number of qualified applicants for the program exceed the number of spaces available, the director reserves the right to give priority to students who have not already participated in a study group or extended study. Programs are subject to meeting minimum enrollments to run.
3. If accepted into the exchange program, you will be asked to sign a contract confirming your participation in the program. You will also be required to complete Colgate's Acknowledgement of Risk and Responsibility form, the Parental Acknowledgement of Student Participation form, and the Physician's Report form, all of which must be completed and signed in order for you to participate in the program.
